### **County Courts -**

County courts have original jurisdiction in probate matters, violations of city ordinances, juvenile court matters, adoptions, eminent domain proceedings, preliminary hearings for felony cases, and civil cases where the amount of money in controversy is under \$52,000. County Court proceedings can be appealed to the Nebraska District Courts.

### **District Courts -**

District courts have original jurisdiction in felony cases and civil cases where the amount of money in controversy is over \$52,000. They also have appellate jurisdiction in certain cases that come out of the County Court. District court decisions can be appealed to the Nebraska Court of Appeals and the Nebraska Supreme Court.

### **Court of Appeals -**

The Nebraska Court of Appeals is the state's middle level appellate court. There are six judges in the court, who sit on panels of three judges each.
